## Hudson-Webber Foundation awards \$550,000 in new grants

DETROIT – At their December meeting, Hudson-Webber Foundation's Board of Trustees approved two new grants totaling \$550,000 for initiatives that provide legal assistance to remove barriers to employment for people with criminal records, and contribute to major renovations for a proposed community organization hub in the Woodbridge/Core City neighborhood.

Also at its final meeting of 2020, the board approved in-memoriam gifts totaling \$20,000 to the Community Foundation of Southeast Michigan (CFSEM), for its COVID-19 Relief Fund and the Michigan Justice Fund, created in 2020 with major seed funding and program development support from Hudson-Webber, to honor the memory of Joseph L. Hudson, Jr., former president, chairman and lifetime honorary trustee of Hudson-Webber Foundation, who passed away on Dec. 2. Hudson was also the founding chair of CFSEM from 1984 to 2003.

"During a year when so many of our friends and neighbors experienced loss and hardship, we remain focused and inspired to carry on Mr. Hudson's lifelong commitment to the advancement of collaborations that build a more equitable future for all Detroiters," said Melanca Clark, president and CEO of Hudson-Webber Foundation. "In reflecting on the breadth of Mr. Hudson's legacy of bringing people together to take on the challenges that have defined the last six decades of our region's history, we take great pride in continuing our support for institutions that bear the mark of his leadership."

## Safe & Just Communities

 <u>Detroit Employment Solutions Corporation:</u> has been awarded a \$300,000 grant to support Project Clean Slate (PCS) the City of Detroit's expungement initiative, to help Detroiters clear eligible criminal records to remove barriers to better employment, education, and housing opportunities.

## **Built Environment**

Allied Media Projects has been awarded a \$250,000 grant to renovate the LOVE
Building in the Woodbridge / Core City neighborhood as a local-national hub for social
justice that integrates community connectivity with restorative and universal design
principles.
